Pursuant to A.R.S. 38-431.02, notice is hereby given that on July 22, 2015, the Game and Fish Public Safety Personnel Retirement System Local Board will meet at 1:00 p.m. at the Arizona Game and Fish Department, 5000 West Carefree Highway Phoenix, Arizona in the Shrike Room. Members of the Public Safety Board will attend either in person or by telephone conference call. The meeting is open to the public. The Board may discuss and take action on the following matters:

**7. Call to the Public**


